Maybe you haven't met, but they don't like you. They even hate you. Among many liberals, support for the 2nd Amendment constitutes a monstrous act of inhumanity worthy of scorn, derision, and social banishment. This harsh lesson was brought home to me during my 25 year tenure in public education at the hands of liberals preaching diversity and tolerance. One day two female students came by my classroom visibly upset over what their debate teacher had just said. Discovering they were on the high school's trap team, she said in front of the entire class; "Girls like you who learn to shoot, especially on the Trap Team, grow up to become mass murderers and killers." She was serious. Asked what to do, I suggested they share this with their coach.4 In May of that year, (2001), Paul G., a student in one of my government classes, revealed his biology teacher told the class anyone who disagreed with her was "one of those crazy conservatives" and the "dumb Republicans are owned by the NRA." She added; "You know what would be funny? If somebody shot Charlton Heston." My point; you can't make compromises and concessions with the Left in an attempt to save any aspect of a right. To do so is like bargaining with assassins over whether they should kill you on Monday or Friday.

While researching my Masters' thesis at the Truman Library, I worked with thousands of declassified documents many redacted in whole or part. referencing documents with recent historical exposes, defector memoirs, and other sources, I was able to deduce the identities of some redacted names, British Secret Service (MI6) and Red Spy Queen Elizabeth Bentley, for example. Redaction frustrates historians because it stymies a full, truthful, and accurate accounting for an historical period. Truman was no communist and, unlike FDR, had no affection for Josef Stalin. But he recognized if the magnitude of the spy scandals got out, Republicans, who had been out of power in Congress and the White House since 1932, would spring on it to hammer Democrats possibly retaking control of Congress in 1946 and the presidency in 1948. Teaching must be in lockstep with approved curriculum and curriculum is written by liberals. Standardized testing, to which state and "federal" (sic) funding is in part tied to, requires students learn only that liberal infused curriculum. What role, therefore, could there be for conservative teachers? Rare if they can be hired in the first place, should liberals uncover one in their midst, he probably won't be around for long. Likewise, hand holding with gun confiscationist organizations, the liberal media redacted mention of President Obama's PROMISE Program and Nikolas Cruz, the Parkland, Florida mass murderer. Consequently, minorities are far likelier to have contact with the police and enter the criminal justice system, the school "pipeline to prison," than white students. "Restorative Justice" was Obama's remedial slogan. But did/does it work?

When minority students are involved in serious cases of "theft, vandalism, trespassing, drug or alcohol possession, or disorderly conduct," [fighting, beating up other students] instead of calling the cops, "troubled-youth" [punks, bullies, drug-dealers, hoodlums, thugs, etc.] are diverted from the discipline process to counseling and "behavioral services." The "benefit" is, troubled youth avoid the proverbial pipeline to prison. The drawback is, these hoods acquire no criminal record thus allowing continuance in their wicked ways, even buying guns. In Florida, these programs are administered in collaboration with the "NAACP, Public Defenders' office, State Department of Criminal Justice, State Attorney's Office, and the Broward County Sheriff's Department." It's de-

signed to give "troubled-youth" second, and in Cruz's case, dozens of second chances.¹⁰ Gangbangers, violent psychos, rapists, bullies, and drug-dealers remain in the classroom seated next to your sons and daughters.


At this writing there is conflicting information as to whether or not Cruz was in the PROMISE Program although the consensus is yes. Deputy Jeff Bell, President of the Broward County Sheriff's Deputies Association, observes that if Cruz, recommended over and over for counseling services, had instead been arrested (trespass and various acts of disorderly conduct), he wouldn't have legally been able to buy a firearm. 11 Obama's PROMISE Program was "pioneered" by "Obama-connected" Broward County School Superintendent Robert Runcie. He implemented it at Marjory Stoneman-Douglas High (MSDH) in 2013, where Cruz attended. He bragged his program reduced "student misdemeanor arrests by 63 percent, expulsions among general-education students [called regulareducation where I taught] by 27 percent, and 54 percent among exceptional education students [Special-Education where I taught] and suspensions by approximately 30 percent.¹² You get more of what you subsidize. Not only are kids saved from accountability for their actions through diversion, their crimes and contact with administrators at times goes unreported and undocumented. Abracadabra, with the wave of the liberal's magic wand, reporting of incidents of crime, including violence, bullying, sexual assault, and suspension drop dramatically because in some cases, they are no longer documented, they don't exist. You can't punish what was swept under the rug. Never happened. Kids, especially those in "protected groups," are spared having to face the consequences of their behavior. Do you think they don't figure this out? What a great way to prepare them for the real world. This is what Runcie did. Instead of arrest and accountability, they get a hug. For this Runcie was named Florida Superintendent of the Year (2015) and won millions of dollars in state and "federal" (sic) grants.13 For teachers desiring promotion, to teach the "desirable" courses, and even to hold on to their jobs, they'd better keep their mouths shut and be a "team player" or else.

Under Obama's PROMISE Program, school districts were "encouraged" to dispose of crimes including "assault, sexual violence, and drug possession" (see the pattern forming?) in-house not reporting them to the police enabling bad kids to graduate without criminal records. School administrators have a self-interest lying to the state and parents about what goes on in their schools. To pump up enrollment, academic ranking, and win support for incessant property tax levies and bond measures, administrators must paint schools in the best possible light possibly fudging student attendance, academic achievement, and crime statistics. Funding for schools and massive cafeteria programs, where your dollars go to feed someone else's kids, are tied, in part, to attendance rates. Truant kids and those suspended or in jail, are detrimental to those rates and funding. Hence some kids get a stay-out-of-jail or "never-go-to-jail" card.¹⁴

In Parkland, Florida, Nikolas Cruz introduced himself as a "school shooter" long before his rampage. His school psychiatrist (May 3, 2014, the year before Superintendent Runcie won his award) revealed Cruz described dreams of "killing people" and seeing them "covered in blood." School officials developed a safety plan to remove sharp objects and weapons from his home and teachers received emails warning that Cruz was dangerous, had made threats, and wasn't allowed on campus with a backpack because he had been found with ammunition on his person. Peers say Cruz talked

about shooting up the school on Instagram, information that was given to the Office of the School Resource Officer as well as Broward County Sherriff's Department. Law enforcement tip lines received numerous calls about Cruz (2008-2017) warning he was violent, mentally unstable, had weapons and planned to shoot up the school. Police interviewed Cruz but did nothing. No effort was made to have him adjudicated mentally incompetent and remove his firearms. Apparently selling knives from a lunch box at school wasn't enough to get Cruz arrested either. He often discussed killing parents and others on social media. Ex-girlfriend Ariana Lopez reported to school officials that Cruz was dangerous and stalking her but they did nothing.¹⁵

Following Cruz's massacre of classmates and teachers, Runcie and other school officials raced to microphones claiming they had had no warnings, phone calls, or threats to indicate Cruz was dangerous. None of these denials were true. The failure of *Welcome-Back-Coddler* and other misguided little or no discipline programs have begot a growing cohort of violent unhinged kids in American society. Liberals, terrified of being called the label they so eagerly lather all over everyone else; "racist," and because they are so arrogant, considering themselves the anointed saviors of society, can never admit they are wrong. It is a good day for Liberty.

President Trump has referred to members of the MS-13 gang as "animals." I have read about MS-13 activities. Their catchphrase is "Kill, Rape, Control." Animals don't do those things. Some kill for food. Some fight for territory or position in the pack; these are rarely to the death. There is a debate in certain circles over whether chimpanzees have engaged in warfare. Some claim this is only due to loss of food resources but they do share 98% of human DNA. There are reports of wild dogs killing livestock seemingly for practice. Dogs have been around our campfires for a long time. We have been a bad influence.

I keep seeing T-shirts with a Second Amendment message over a skull. Please stop wearing these shirts. It links the Second Amendment with death. That is the message the opposition is trying to spread. Do not help the opposition. I know, the people wearing them think they are saying they will defend their rights to the death. That is not the message that is being received by the public.

Years ago I had a cartoon made which showed a lady knocked to the ground by a rapist. The lady is pointing a revolver and asking "How would you like a .38 vasectomy?" I thought it was a great message; but it was not popular.

A lawyer from Pennsylvania told me about a case he overheard. The defendant was charged after a search warrant was issued for his home. The basis for the search warrant was that he had seven (7) semi-automatic rifles. It was not illegal to have semi-automatic rifles in the jurisdiction but the police and prosecutor and judge believed that such a collection indicated some type of illegal activity. My informant buttonholed the defendant's lawyer and advised him to get the warrant suppressed. The authorities were using legal activity as suspicion of criminal activity. The other lawyer refused. He thought it perfectly reasonable to search a home with such a collection of guns. The Fourth Amendment protects us from "unreasonable searches and seizures." Some people have an odd idea of what is reasonable.

I've had another one of those upsetting cases. One I thought I could win, one that should never have been filed. But, my client has lost faith in the system of justice and instructed me to plead guilty. I'm told that I should not let these things upset me. On reflection, when these things no longer upset me, it is time to quit.

Two famous persons have committed suicide. Consequently the subject is in the papers. One correspondent wrote that two states enacted "red flag" laws allowing guns to be seized on minor evidence of danger to the person or others. The correspondent assures us that these states then enjoyed a reduction in "firearm" suicides. Notice the qualifier "firearm." Suicides by any other means are not counted. I had a client who saw a car swerve out of its lane and speed head on into her pickup. This was clear suicide; which also severely injured the woman and her child. Dead is dead regardless of the weapon used. The usual suspects frequently lie with statistics by shifting definitions like this. If all they have done is move suicides to another weapon then all they have done is annoy a number of innocent persons. The usual suspects do not care and in fact annoying innocent parties may be their objective. Making guns inconvenient to own is their intermediate objective of making them rare and then illegal.

A lengthy article in the local tabloid presents Democratic candidates for governor as gun "moderates." This means they only want to take away part of our rights; this time. The old story "I support the Second Amendment but . . ." They are a bunch of buts.

The usual suspects display an appalling ignorance of the area they intend to regulate. They say that normal-sized magazines turn guns into automatic weapons.

There is a movement to ban tobacco and another to legalize marijuana. This is America. Liberty does not have to make sense.

Reading through the Bill of Rights I notice that it seldom states absolutes. We are protected against "unreasonable" searches and seizure. Other amendments have exceptions. The Second Amendment states that it "shall not be infringed." This is the most absolute of the rights. Even opponents of gun rights have admitted that this is the most absolute of the Bill of Rights. Yet, here we are protecting it from infringement and trying to recover it from many past infringements. The Supreme Court has not established a standard of review for Second Amendment cases. It has refused to take cases which government action clearly violates the Heller and McDonald decisions. Justice Thomas has complained in dissent that the Court treats the Second Amendment like a second-class right. The standard of review is critical. The two base standards are Strict Scrutiny, in which the government almost always loses, and Rational Basis, in which the government almost always wins. Appellate courts have been compromising our right with "Intermediate Scrutiny." This is somewhere between the two. We have been losing these cases because this level of scrutiny can mean anything the judge wants. Some commentators say that we should wait for another originalist justice to be appointed before taking up a case. Right now there are four hard votes against us and four hard votes for us. Our right depends on what Justice Kennedy thinks it means. He has voted our way in the past but is considered a soft vote. It may be that Justice Scalia did not establish a standard of review is because he could not get five votes for the strict scrutiny standard he was clearly going for. To get another originalist justice we need a president who will appoint such a judge and a senate which will confirm him or her in the position. We need to work towards that end.

Illinois judge blocks village's ban on semiautomatic rifles, magazines

Gun-rights advocates scored a notable win last week when a judge blocked the enforcement of a Chicago suburb's new ban on semiautomatic rifles and high-capacity ammunition magazines, saying the village of Deerfield went further than state law allows.

Second Amendment supporters had warned the law would have not only stopped new purchases but could have been the basis for confiscations.

State Circuit Judge Luis Berrones said Deerfield's ordinance, approved in April, amounted to a new ban on weapons. He said Illinois law delegates such authority only to the state.

His decision, which temporarily halts the law, came just before it was to take effect June 13.

"This ruling is a significant victory because it allows law-abiding Deerfield residents to keep commonly owned firearms and magazines in their homes for self-defense while the case proceeds," said John Boch, executive director of Guns Save Life, one of the plaintiffs in the lawsuit challenging the new rules.

American Medical Association goes all-in for gun control, turning doctors into police state enforcers

The American Medical Association (AMA) is a powerful organization that defines medical education and medical practice in the U.S. The organization creates policies for all physicians to follow and they can threaten a doctor's medical license if they do not follow along. In 2018, the AMA has decided to support gun control as a public health issue.

AMA's new gun control push turns doctors against patients

Many physicians aren't going to follow suit with this <u>insidious gun control agenda</u>, because many doctors are gun owners too, and they want to respect the privacy of their patients. Many physicians aren't going to be a police state enforcer, turning in their patients because they own a scary-looking rifle or a 14 round "high capacity" magazine. Physicians should be smart enough to know that "assault" is an action, not an object. Naming a class of firearms as "assault weapons" doesn't make these objects more dangerous.

Notwithstanding, there will still be those doctors who bow down to the AMA and become snitches for the Marxist gun control agenda. Claiming that they are "improving public health" by removing firearms from the streets, these lackey doctors will do the "heroic" work of turning in their "high risk" patients who own firearms. All the while, these doctors will prescribe psychiatric drugs that provably cause violent behavior and suicide.

AMA President Dr. David O. Barbe spoke to association members at a recent meeting, decrying that physicians "must not back down from addressing gun violence." Among their policies for "addressing gun violence," the AMA calls for ensuring that schools remain "gun free zones" with no actionable plan to protect students from attacks. Individuals who have not committed a crime could be declared "high risk" by a paranoid, gun-illiterate physician. Are doctors who push pills even capable of making that judgment?

Dr. Barbe believes that "high capacity" magazines, which are defined as having more than 10 rounds of ammunition, are part of the problem. The AMA also calls on Congress to ban "assault-style" rifles, such as the Armalite-15. According to Dr. Barbe, only government officials and military service people are allowed to possess magazines with more than ten rounds. Only authority can carry rifles that can be fired semi-automatically.
